Floxin is a quinolone antibiotic used in respiratory infections and pelvic and reproductive infections.			
Rarely, quinolones can cause tendon sheath rupture, usually of the Achilles.			
At the first indication of tendon pain, the antibiotic should be discontinued.			
QUESTION 2			
The only time that an individual may receive medical care without giving informed consent is			
A. when the durable power of attorney for health care is not available			
B. in an emergency, life-or-death situation			
C. when the physician is not available for discussion with the client			

Correct Answer: B

Treatment may be given without consent in a life-threatening situation. Choices "when the durable power of attorney for health care is not available", "when the physician is not available for discussion with the client", "when they (clients) are not able to speak for themselves" are incorrect. All attempts to notify a durable power of attorney for health care should be made. If unavailable, the physician assumes responsibility for treatment within facility protocol. The physician is obligated to have a discussion with the client in all non- life-threatening situations. If clients are not able to speak for themselves, their power of attorney for health care or responsible party is involved in the consent process.

D. Adjuvant medications can be purchased over the counter.

Correct Answer: D

Adjuvant medications, used to increase the effects of the opioids and nonopioid medications.

These medications include anxiolytics, anesthetics, anticonvulsants, nonsteroidal analgesic medications and topical local anesthetics. Some of these medications, like ibuprophen, are available over the counter and they act on pain by deadening the nerve endings in the skin.
